

2020 UNITY BANK CAR SHOW SWEEPSTAKES OFFICIAL RULES

The 2020 Unity Bank Car Show Sweepstakes ("Sweepstakes") starts at 12:01 a.m. ET on June 3, 2020 and ends at 11:59 p.m. ET on June 30, 2020 ("Promotion Period").

ENTRY: To enter the Sweepstakes, complete and submit the contest entry on www.unitybank.com. This method of entry is referred to herein as the "On-Line Entry Method". Entries are limited to one (1) entry per person. The Sweepstakes ends on June 30, 2020 at 11:59 p.m. ET, which is the deadline for entries completed by the On-Line Entry Method.

PRIZES: One (1) First Prize of \$100 each (collectively, the "Prizes" or, if individually, the "Prize") are available to be won. Six (6) Runners-up Prizes of \$50 each (collectively, the "Prizes" or, if individually, the "Prize") are available to be won. Four (4) Runners-up Prizes of \$25 each (collectively, the "Prizes" or, if individually, the "Prize") are available to be won. The total estimated retail value of all Prizes to be awarded is \$500.00. Prizes may not be transferred or exchanged except at the discretion of the Unity Bank. Taxes are the sole responsibility of each of the Prize winners ("Winners" or, if referenced individually, each a "Winner"). Winners may be required to sign an IRS W-9 or its equivalent.

WINNER SELECTION: Winners will be determined on or about July 13, 2020 by Unity Bank representatives, in a random drawing from all eligible entries received. Each entrant will be eligible to win only one Prize. Odds of winning the Sweepstakes will be determined by the number of eligible entries received by both methods of entry. Winners will be notified by mail, phone, and/or e-mail. Return or rejection of the Prize notification within 5 days for any reason will cause the Prize to be forfeited and awarded to an alternate winner (also randomly selected from all eligible entries).

ELIGIBILITY: The Sweepstakes is open to legal residents of New Jersey, Pennsylvania, or New York who are 18 years of age or older at the time of entry. Employees (and their immediate families and persons who reside in the same household) of Unity Bank, are not eligible to enter into or win the Sweepstakes.

GENERAL: Void where prohibited. By entering the Sweepstakes, you accept and agree to be bound by these rules and all decisions of the Sweepstakes Entities, which are to be deemed final.
